b. Routes:

All GA Domestic & International routes (include interlining and exclude MEA).

- c. Eligibility:
 - Valid for FIT/Individual only.
 - Not Valid for corporate pax.

d. Class: ALL SUB CLASS ON FIT FARE.

e. DOI: 01Jul20 - 31Jul20.

(fresh issued only, valid for reservation on/after 01Jul20).

f. DOT: 01Jul20 – 20Jun2021 (Complete travel).

g. Endorsment Box: GREATER FLEXI / RZ10114GA20/xxx

(must be put manually during reissuance)

xxx: number of changes occurred: 1st Changes / 2nd Changes

h. POI: All GA Channels.

(website, mobile, OTA, GOS, Contact Center, GASO, Gerai, Travel Agent)

i. Method: By Auto pricing

j. Penalty:

Free changes fee max 2/two times until 31 December 2020 (complete reissued)

Valid for new DOT until 20JUN21 (complete travel)







- Different fares & taxes is collected.
- Changes processed at GA ATO/ CTO/ CALL CENTER/ TRAVEL AGENT
- No show fee applied as follows:
 - ✓ DOT 19Jun20 19Jul20 : Penalty will be charged based on Reservation cancelled
 - ✓ DOT 20Jul20 31Aug20 : Penalty will be charged based on Ticket Processed
 - ✓ For Tickets with DOT 19JUN20-31JUL20 which PNR cancelled already before 13JUL20 then all penalties scheme can be calculated based on when passenger cancel their reservation

Domestic ticket:

First / Business Class : 50% from basic fare
Economy Class : 100% from basic fare
International ticket : USD100 per ticket

DOT 01Sep20 - 20Jun21: Penalty will be charged based on Ticket Processed

FIT F/P/A/J/C/D/I/Y: 10% from basic fare FIT B/M/K/N/Q/T/V/S/H/L: 40% from basic fare International ticket: USD100 per ticket

Reissued On/After 01Jan2021

- Changes fee is collected refer to applicable fare rule used
- Different fares & taxes is collected.
- Changes processed at GA ATO/ CTO/ CALL CENTER/ TRAVEL AGENT

Refund:

- Refund fee is free. Refund by exchanges the ticket into travel voucher (EMD voucher) only.
- Travel voucher (EMD voucher) can be used for buying GA ticket, issued & travel until 30Jun2021 complete travel (only valid for GA operating).
- Travel voucher (EMD voucher) is not refundable for all payment method.
- If pax insist to refund to original FOP penalty applied refer to fare rule used and refer to approval GM/AM BO untuk ticket issued offline & EC/CD for poi online channel.
- Refund processed at GA ATO / CTO / CALL CENTER.
- No show fee applied as follows:
- ✓ DOT 19Jun 19Jul20 : Penalty will be charged based on Reservation canceled.
- ✓ DOT 20Jul 31Aug20 : Penalty will be charged based on Ticket Processed.
- ✓ For Tickets with DOT 19JUN20-31JUL20 which PNR cancelled already before 13JUL20 then all penalties scheme can be calculated based on when passenger cancel their reservation.

DOT 01Sep20 - 20Jun21: Penalty will be charged based on Ticket Processed

FIT F/P/A/J/C/D/I/Y: 10% from basic fare FIT B/M/K/N/Q/T/V/S/H/L: 40% from basic fare International ticket: USD100 per ticket

k. Tour code: RZ10107GA20

Must be put manually on the ticket
